Power Comes at a Cost – Senate up for grabs?

- Governors: 24 Democrat/26 GOP +10 gain since 2016
- House: 241 GOP in 2017 197 today 115 left/retired/defeated
 - 43% turnover

HEALTH CARE SYSTEM

• Public Health Preparedness: What went wrong and how to remedy gaps before the next outbreak? How to target populations most in need?

- Hospital Surge Capacity: How to ensure adequate capacity and in-time access to key equipment?
- Health Coverage: What are the roles, responsibilities, and gaps in private and public insurance? Who has access to mental health services? Who doesn't?
- Health Disparities: What structural changes are needed to address underlying inequities?
- Privacy, Tracking, Tracing and Hacking: How to protect health data and consumer privacy?
- Price Gouging and Pandemic PPE Profiteering: Who's to blame, how to remedy?
- Paid Sick Leave: Did the lack of this benefit worsen the spread of the disease by infected workers?
- CARES Act Supports: Who got funds, how were they distributed, and what were they used for?

ECONOMY & SOCIETY

• Shutdowns: Did costs of economic closures outweigh benefits? How do we manage future and rolling outbreaks?

• Safety Nets: Why did they fail the most vulnerable (by race, income, age, health)? How do we fix them?

• **Remote Learning Inequities**: What disparities emerged and how do we bridge digital divides? How has learning in K-12 been impacted? College costs?

• **Protecting Essential Workers**: Did critical essential workers (health providers, warehouses, meat plants, drivers) receive adequate protection and fair pay?

• The "Info-demic": Was there too much misinformation online or too much censorship?

• Small Business Revival: What will it take to restore Main Streets? Are dominant "tech" players too powerful?

GOVERNMENT PREPAREDNESS & RESPONSE

• **Testing Failures:** What went wrong with CDC testing and why has the U.S. badly trailed other nations?

- CARES Act Supports: Who got the \$3T, how did they get it and what did they use it for?
- Election Preparedness: How to protect voter health and election integrity in primaries and November?

• State & Local Solvency: Should the Feds bail out everyone, even places over-leveraged before COVID?

Traditional + Modern Advocacy Strategies Tactics and Tools to Advance and Shape Policy Priorities

- Legislative Advocacy –state-federal legislative tools for change
- Judicial Advocacy amicus briefs
- Regulatory Advocacy –filing of public comments/sharing data/evidence
- Industry Advocacy experts/recognized surrogates: CEOs, scientists, psychologists
- Citizen Advocacy –1-1 partnership –long term relationships to champion priorities
- Media Advocacy strategic use of all forms of media
- Diplomatic Advocacy building of networks of allies around issues
- Political Action Advocacy supporting champions
